Town of Caledon is providing a tax assistance program for qualified low-income seniors and low-income persons with disabilities in accordance with Town of Caledon By-law No. 2015-019 which allows for a tax reduction of \$450 against the residential real property taxes imposed by the Town provided that the by-law's eligibility criteria are met.
All applications must be made by December 31st of the current taxation year.
